- When selecting Four Points Technology as a supplier/subcontractor large business, FSIs can obtain small business and SDVOSB credit for their cloud capacity spend by awarding orders to Four Points Technology under an appropriate NAICs code. Converting cloud capacity to a small business purchase can free up significant headroom for the FSI Prime to deliver their own high value technical resources while meeting small business goals.
- In addition to AWS, we resell the other FedRAMP hyperscale CSPs (Azure and Google) and have all three directly on our GSA Schedule. When partnering on GSA or a GSA-based BPA, FSIs can propose Four Points Technology as a CTA partner and may be able to offboard low-margin Cloud resale completely from their program P&L.
- We can deliver cloud to the government at the same or lower cost than buying direct. With relatively low overheads, we can generally meet FSI's required price points and do not charge for our operational billing and reporting services.
- CSPs continue to recognize the FSIs revenue attainment and launches even when we act as the reseller.
- Should the FSI want to include AWS-delivered ProServe, training, or managed services in their offer, we are experts in managing contract flow downs that AWS may not accept directly and supporting the on-boarding, reporting, and deliverables associated with subcontracting for AWS professional services.
- While FSIs typically have strong AWS teams focused on technical solutioning, the Four Points Technology AWS team is complementary -- focusing on supporting operational functions with rapid, effective escalation within AWS.
- We are experts in cloud economics/FinOps -- optimizing cost structures through consolidation, annual and multiyear volume commitments, and best-fit instance sizing.
